Dear Chairman Pallone, Ranking Member McMorris Rodgers, Chairwoman Eshoo and Ranking Member Guthrie:

On behalf of the millions of individuals in and seeking recovery and their loved ones, we are writing to express our deep disappointment that legislation your Committee is about to consider, the Restoring Hope for Mental Health and Well-Being Act of 2022 (HR 7666) does not include a 10% Recovery Support Set-Aside in the Federal Substance Abuse Prevention and Treatment Block Grant (SABG), now being considered by the Committee as the "Substance Use Prevention, Treatment, and *Recovery Services* Block Grant Act of 2022," and an accompanying 10% increase in the SABG's authorization in upcoming legislation to reauthorize the Substance Abuse and Mental Health Services Administration (SAMHSA). Regrettably, the undersigned organizations cannot support the bill in its current form.

We understand there have been concerns raised about the set-aside limiting state flexibility, but we find such concerns to be contradictory in light of support for the 20% set-aside for prevention. For example, on April 5, 2022, Cassandra Price testified on behalf of the National Association of State Alcohol and Drug Abuse Directors in favor of the 20% set-aside for prevention stating that "This 'prevention set-aside' is a core component of each State's prevention system. In particular, SAPT Block Grant funds make up more than 60% of primary prevention funds managed by State alcohol and drug agencies. In 14 States, the prevention set-aside represents 75% or more of the State agency's substance use prevention budget. In six States, the prevention set-aside represents 100% of the State's primary prevention funding." At the same time, Ms. Price said that "In the context of reauthorization, NASADAD prefers to maintain as much flexibility as possible in the use of SAPT Block Grant funds consistent with the nature of, and benefits related to, the block grant mechanism. The flexibility afforded in the SAPT Block Grant allows States the opportunity to target resources based on the conditions on the ground as opposed to pre-ordained spending requirements."

It is inaccurate to characterize the social and community benefit of a 20% prevention set-aside any differently than a potential recovery set-aside, particularly since there is no other dedicated funding source for recovery support services.

Without the dedicated funding stream provided by the set-aside, recovery support will continue to be woefully underfunded. Today, there is in an astonishingly low number of recovery support services, including just 200 collegiate recovery programs, 160 local communities with a Recovery Community Organization, and 40 recovery high schools compared to over 15,000 specialty addiction treatment programs or the over 5,000 prevention coalitions nationwide. This disparity is particularly troubling in light of recent Centers for Disease Control and Prevention data estimating that 105,752 Americans died from overdoses between October 2020 and October 2021 – the highest rate of overdose deaths on record.

A set-aside would establish a dedicated funding stream for recovery support services that have not previously existed. Although funds spent on substance use disorder treatment in SABG and the State-Opioid Response (SOR) grants are "eligible" to be spent on non-clinical recovery-oriented supports, there is significant variability in how each state determines how these funds will be used. Additionally, definitions of treatment and recovery support and allocation of expenditures on each vary widely among states as documented in the December 2020 GAO Report to Congress.¹ As such, we also support the inclusion of accompanying transparency language that would ensure that it is clear where and how these funds are spent.

To dramatically reverse the troubling trend of increasing substance misuse and overdoses in our country, it is imperative that the response to the substance use disorder crisis evolves from an acute short-term individual-focused treatment response to a broader community recovery response where states and non-governmental organizations work in partnership to provide the entire continuum of care.

We appreciate the Committee's focus on mental health and substance use, but believe that HR 7666 will fail to meaningfully address the substance use disorder epidemic in our nation and reduce the number of substance use-related deaths and we cannot support the bill in its current form. We ask that a 10% Recovery Support Set-Aside in the SABG and a 10% increase in the SABG's authorization in SAMHSA reauthorization legislation be added to the legislation. Such funding would allow all varieties of recovery support services to save lives immediately and dramatically scale recovery capital in communities across the country.
